

**I consent to the processing of my personal data by PFR Towarzystwo Funduszy Inwestycyjnych S.A.**

I also declare that I have been informed that:

1. the Administrator of my personal data is PFR Towarzystwo Funduszy Inwestycyjnych S.A. with its registered office in Warsaw at Krucza 50, 00-025 Warsaw, phone number 22 341 70 00, e-mail: [kontakt@pfrtfi.pl](mailto:kontakt@pfrtfi.pl) („PFR TFI” or „Administrator”),
2. the Administrator has appointed a Data Protection Officer, whom I can contact in the following manner:
  - a. in writing – to the address indicated above with the note „Data Protection Officer”,
  - b. via e-mail – to the e-mail address: dane.osobowe@pfrtfi.pl,
3. in case of any questions concerning the method and scope of processing of my personal data, as well as my rights, I can contact the Data Protection Officer,
4. my personal data will be processed for the purpose of:
  - a. contacting me by PFR TFI to the extent necessary to consider the complaint, pursuant to Article 6(1)(a) of the Regulation of the European Parliament and of the Council (EU) 2016/679 on the protection of natural persons with regard to the processing of personal data and repealing Directive 95/46/EC („GDPR”),
  - b. the handling of complaints, requests and appeals, pursuant to Article 6(1)(b)-(c) and (F) of the GDPR,
5. my personal data will be stored for the period necessary to contact with me and appropriately handle the complaints, requests or appeals I have submitted, but no longer than 5 years from the end of the year in which PFR TFI received the complaint. If the processing of my personal data is based on the consent I have provided, my data will not be processed longer than until the consent is withdrawn,
6. my personal data may be transferred to:
  - a. external entities cooperating with PFR TFI to the extent necessary to handle the complaint,
  - b. entities and bodies to whom the Administrator is obliged or authorized to disclose personal data under generally applicable law, including entities and bodies authorized to receive personal data from PFR TFI or entitled to request access to personal data under generally applicable law,
  - c. service providers supplying the Administrator with technical and organizational solutions enabling the management of the Administrator’s organization, including entities operating IT systems or providing IT tools to the Administrator, particularly those offering IT support services or legal services to the Administrator,
  - d. entities processing personal data on behalf of the Administrator – provided that such entities process the data based on a contract with the Administrator and exclusively in accordance with the Administrator’s instructions,
7. my personal data will not be transferred outside the European Economic Area or to international organizations,
8. I have the right to:
  - a. access my personal data,
  - b. rectify my personal data,
  - c. erase my personal data (right to be forgotten),
  - d. restrict the processing of my personal data,
  - e. object to the processing of my personal data.
9. I have the right to withdraw my consent to the processing of my personal data, and the withdrawal of consent does not affect the lawfulness of the data processing that took place based on the consent before its withdrawal,
10. I have the right to lodge a complaint with the President of the Office for Personal Data Protection,

11. the personal data I have provided is necessary to fulfil my request for contract, handle the complaint, request, or appeal,
12. my personal data will not be processed by automated manner, nor will it be subject to profiling.

Providing personal data is voluntary however it is necessary for PFR TFI to contact me to handle the complaint submission.
